General Membership Meeting Minutes

4/28/2010

I. Call to order

President Keith Ash called to order the General Membership meeting of the **Green Country Soccer Association** at **7:08pm** on **4/28/2010** in **the offices of the Green Country Soccer Association**. Quorum was established at 613 votes.

II. <u>Roll call</u>

The following clubs were present: Catoosa, Central Tulsa, Claremore, Inola, Miami, Oolagah, Owasso, Skiatook, Tulsa United, Union, Washington County.

The following clubs were absent: Beeline, Bixby, Broken Arrow, Cleveland, Collinsville, Coweta, Drumright, Ft. Gibson, Goingsnake, Grand Lake, Metro Tulsa, Mannford, Mayes County, Muskogee, Porter, Sand Springs, Sapulpa, Stilwell, Tahlequah, Verdigris, Wagoner

III. Approval of minutes from last meeting

Secretary/Treasurer Mark Usrey presented the minutes from the 2/24/2010 General Membership meeting in printed form. Washington County moved to accept as printed, Owasso seconded. **Motion approved.**

IV. Officer Reports

- a) Jeanette Rooks reported that the G&D had made 24 game determinations, reviewed 15 ejections (3 coaches). They called in 3 players for additional hearings, resulting in 1 receiving an additional suspension. She urged the clubs to work on parent behavior on the sidelines and start emphasizing sportsmanship.
- b) Doug Lynch reported that the Competitive Commission had established May 6, 2010 as the date that competitive clubs were to have information for the tryout circular to him in preparation for publishing.
- c) Robert Allen reported on the upcoming GCSA Scholarship Tournament. Team count is down so far. He believes that it might be due to the Kohl's/Governor's Cup being held so close (both in date and location). He provided some flyers to hand out to teams. Some of the larger clubs are not participating at the same level as the smaller clubs and that needs to be addressed.
- d) Mark Usrey presented financial statements for the organization and provided general comments about the condition of the organization.
- e) Keith Ash reported that GCSA had 12,793 players registered this spring. In the spring of 2009, we had 13,641 resulting in a decrease of 848 players. This is generally better than the upswing between 2008 and 2009, but we need to focus on getting players back into the system.

VI. <u>New Business</u>

- a) Jeanette Rooks presented a bylaw change. Article 5 of the bylaws dictates the date and time of the General Membership meetings. We have been meeting on Wednesdays to get better attendance. She proposed that the bylaw be changed to read "the General Membership meeting shall be held at some time during the last full week of January, April, August and October". Oolgah moved to accept the change, seconded by Miami. Motion passed.
- b) Jeanette has been cleaning the storage closet and asked members present to take any equipment that might be needed by their clubs.
- c) Union asked to distribute some 3v3 flyers to the membership attending.
- d) A nominations committee was created for identifying candidates for the 1st VP, 2nd VP and 3rd VP positions on the Executive Board due to be elected at the August General Membership meeting. Kaye Conley of Owasso volunteered to chair the committee. Bob Sweet and Teresa McConnal from Claremore will also serve on the committee.
